

## APRIL 2024 POWDER GETAWAY CONTEST

## **OFFICIAL CONTEST RULES**

**ELIGIBILITY:** Selkirk Tangiers Heli Skiing and Revelstoke Mountain Resort's "**April 2024 Powder Getaway Contest**" (the "**Contest**") is open to residents of Canada (and the United States of America (excluding Florida and New York State), who have reached the age of majority in the province or state in which they reside at the date of entry. ## Grand Prize Conditions:

- The Sutton Place Hotel: Based on availability, accommodation will consist of Three nights in a 1-Bedroom Suite. Either the winner or his/her guest must be at least 19 years old and must have a valid credit card. The winner will be responsible for all incremental charges incurred during their stay.
