

THE REVELSTOKE WINTER GETAWAY CONTEST

OFFICIAL CONTEST RULES

ELIGIBILITY: Revelstoke Mountain Resort's "**Winter Getaway Contest**" (the "**Contest**") is open to residents of Canada (excluding Quebec) and the United States of America (excluding Florida and New York State), who have reached the age of majority in the province or state in which they reside at the date of entry. Employees, representatives and agents of Revelstoke Mountain Resort are not eligible to enter. Void where prohibited by law.

SPONSOR: The Sponsor of this Contest is Revelstoke Mountain Resort, with an address at 2950 Camozzi Road, Revelstoke, BC, V0E2S1, Canada.

HOW TO ENTER: No purchase necessary to enter or win. A purchase will not improve your chances of winning. The Contest will begin at 12:00:01 a.m. (Pacific Time) on September 26, 2024 and will end at 11:59:59 p.m. (Pacific Time) on December 15, 2024 (the "**Contest Period**"). Once you've entered the contest, you may also qualify for a bonus contest entry by signing up or confirming your subscription to the Revelstoke Mountain Resort email marketing newsletter at <u>www.revelstokemountainresort.com/contact-us/newsletter-signup</u>. You may also enter by mailing an entry with your first and last name, date of birth, mailing address and phone number to Box 2460, Revelstoke, BC, VOE 2S1, Canada, Attention: Marketing Director.

Participation is limited to one regular entry per person and one bonus entry per person (a maximum of two entries per person – one regular entry and one bonus entry).

The Grand Prize is comprised of the following:
